**ORDER**

**Grounds of Appeal**

The Appellate Authority has received an online Appeal PGCIL/A/2019/60010 dated 31<sup>st</sup> January, 2018 from Sh. Naved. Earlier, the appellant herein had filed an application PGCIL/R/2018/50813 dated 19<sup>th</sup> December 2018, under RTI Act, 2005, with the CPIO Corporate Centre, POWERGRID seeking information regarding recruitment of Executive Trainees (Law) against Advt. No. CC/03/2018 dated 13<sup>th</sup> March 2018.


Appellant has files an appeal on the ground that he did not receive requisite information from the CPIO within the time Limit. On receipt of the Appeal, the details were sought from the CPIO. CPIO informed that response of the RTI has been provided to the applicant vide letter dated 24<sup>th</sup> January 2019.



## Decision

I have perused the letter dated 24<sup>th</sup> January, 2019, of the CPIO, vide which the appellant was informed that the information sought by him cannot be provided being exempted under section 8(1) (j) of the Act. I find force in the observation of the CPIO that the information sought by the applicant (appellant herein) is personal information and its disclosure has no relation to any public activity or interest hence the same cannot be provided. Moreover, the appellant has also sought information related to category and sub category of the candidates which would cause unwanted invasion of their privacy. In view of the aforesaid the information sought cannot be provided.

The Appeal is accordingly disposed of.
