 4. Kindly provide copies of purchase orders placed for O&M spares and consumables imported by your Undertakings for the above referred period through email on excel format or CD format for which I shall remit Rs. 50/- on hearing from you.
 5. Please provide me the contact details of the Nodal Officers / Nominated Officers looking after the implementation of "Make in India" policy in your Undertaking including his / their Names, Designation, email, mobile / land line.
- 1.2 I request to kindly provide me the information and documents sought above referring my this application reference and date to my email i.d. imrkanoi@gmail.com within the prescribed time limit of the RTI Act 2005 or may be sent by post to my address above. In case the information is not available with you , my application may be forwarded to the concerned Public information Officers for providing the information to me directly under Section 6(3) of the RTI Act, with a copy endorsed to me, for my information.
