

Q 1	I downloaded advertisement notice of recruitment of Engineering trainee advt no. CC/07/2018 dated 03.09.2018, I want to know about eligibility. Is AMIE valid for non departmental candidates and departmental candidates, Please describe separately for departmental and non departmental candidates.
Reply	As notified vide Advt. No. CC/07/2018 dated 03.09.2018, the eligibility criteria w.r.t educational qualification for the post of Executive Trainee is as follows: "Full Time B.E./B.Tech/ B.Sc (Engg.) from recognized University/ Institute"  Relaxation extended to departmental candidates: "Part - Time B.E./ B.Tech/ B.Sc (Engg) in Electrical/ Electrical (Power)/ Electrical and Electronics/ Power Systems Engg./Power Engineering (Electrical)/ Electronics/ Electronics & Comm./ Electronics and Telecom./ Electronics & Electrical Comm. / Telecom. Engg/ Civil Engg. Disciplines from recognized Institute/ University is also admissible.  <b>However, no qualification acquired through distance education mode is allowed."</b>
Q 2	What is the scope of AMIE which is conducted by IEI for power grid departmental as well as non-departmental candidates
Reply	Please refer to reply to Query 1.
Q 3	I searched IGNOU website, I found a notice where it is written that AICTE approval not necessary for IGNOU B.Tech. Degree/Diplomas: Supreme Court.  We can also check in IGNOU official website notice date 20-08-2018 and I also downloaded supreme court case order copy which is attached with this rti application. Am I eligible in power grid after completing BTECH from ignou, please describe departmental as well as non departmental candidates separately.
Reply	The query aims to garner opinion/comment on eligibility on the basis of a hypothetical situation. Reply to this query does not come under the definition of "information" as per clause 2(f) of the RTI Act 2005.
