



**MEMORANDUM TO YOUR KIND NOTICE**

**Subject Matter:-** This memorandum is filed before your office to bring to your notice in respect of the power line constructed by two major companies M/s. Kudgi Transmission Limited and M/s. Powergrid NM Transmission Limited as per the work order issued by the central government.

I, Sri. G R Sudheendra, S/o. Late G M Raghavendra R/a. kukke shri ,chethana lay out, 3<sup>rd</sup> cross, 80ft Road, Batawadi, tumkur - 572103, is basically an agriculturalist and also I am one of the active RTI activist fighting against the corruption and also involved myself in may ritha sanga activities in getting the government subsidies and other helpful activities to the best of my knowledge.

I have approached by many farmers (listed below) of the tumkur district and requested to bring to the notice of the Prime minister and power minister regarding the unfair activities done by the M/s. Kudgi Transmission Limited and M/s. Powergrid NM Transmission Limited in construction and lying of transmission lines in the vicinity of the tumkur district.





It is also necessary to state that, I have already filed the memorandum before the State Election commissioner on 05.10.2018 for banning of central election ( M P Election), to be held in the April of 2019, if the proper action is not taken against the unfair act done by the above said two companies while acquiring the land. The state election commissioner had taken action on the representation and given direction to tumkur Deputy Commissioner to take action in respect of the issued framed in the memorandum and the notice is sent on 05.11.2018 to the office of deputy commissioner tumkur.

it is further to bring to your kind notice that, we have taken notice through our counsel date 17.11.2018 to the deputy commissioner and Superintendent of police tumkur district, regarding the unfair acts of the M/s. Kudgi Transmission Limited and M/s. Powergrid NM Transmission Limited and also requested to not to give any support to the said authority in carrying the line work without paying the just compensation to the farmers on the lands acquired.

In spite of our representation before the above said authorities M/s. Kudgi Transmission Limited and M/s. Powergrid NM Transmission Limited have managed the officers of higher rank and their subordinate offices and carrying out the line work, the farmers has also requested the officers of the M/s. Kudgi Transmission Limited and M/s. Powergrid NM Transmission Limited companies to pay the compensation properly as per the guidelines in spite of managing the higher government official. Still as on day two companies are not showing any interest in given the compensation as that this memorandum in carried out to bring to the notice of your kind self.

### **Brief FACTS OF THE CASE**

1. It is submitted that, the livelihood of the below referred family members and other farmers of depending on the income of the land which are subjected to the acquisition for erecting of electric towers and laying of power lines.

2. It is submitted that, the M/s. Kudgi Transmission Limited, having its address at no. 38, Cubbon road, Bangalore -60001, which is registered under the companies act of 1956, has been entrusted to construction of 765 K V D/C (Hexa Zeeva) Narendra (new)- Madhugiri Line required for the evacuation of power from NTPC Kudgi (3X800MV in Phase-I) sanctioned by the government of India vide its letter no. 11/2/2012-PG ( RE TPRCL, NTPC) dated 09<sup>th</sup> July 2013. It is further



submitted that M/s. Kudgi Transmission Limited had specifically carried out the construction of 400 KV ( D/C) line from Madhugiri to Bidadhi and 765 k V ( D/C) line from Narendra (New) to Madhugiri, and 400 kv (D/C) kadapa -Madugiri , which is under the jurisdiction of the Tumkur district and properties are falling under the revenue authority of Tumkur district. The official memorandum issued by deputy commissioner Tumkur in his official memorandum dated 06.02.2016 bearing order no. MAG (I) CR /250/2014-15, confirms the same .

3. It is submitted that, the M/s. Powergrid NM Transmission Limited, having its regional office at Vasanta Narasapura Industrial Area Stage-3, Kempanadodderi Village, Kora Hobli, tumkur district-572138, has been entrusted with the construction of Dharmapuri-tumkur 765KV S/c transmission Line by Government of india Vide its Letter no. 11/2/2011-PG (PFC) dated 22.09.2011. In exercise of the powers, under the Indian telegraph Act, 1885, Part-III, Section 10 to 19 conferred under section 164 of Indian Electricity act 2003, through the Gazette of india, Extraordinary, dated 05.12.2013. it is further submitted that M/s. Powergrid NM transmission Limited, had carried out the construction of 400 KV (D/C) Gooty ( Andhrapradesh to Madhugiri Line and 400KV ( D/C) Madhugiri to Yelahanka Line and 765 KV (S/C) Madhugiri to Dharmapuri ( Tamilnadu) and Madugiri to Kadapa 400 kv (D/C) line as confirmed from the official notification issued by deputy commissioner tumkur in his official memorandum dated 06.02.2016 bearing order no. MAG(I) CR /250/2014-15 .

4. It is submitted that, The Deputy Commissioner of Tumkur District is the authorized office to carry out the compensation formalities for the land being acquired by the above said respondent no. 1 to 2 for the purpose of the construction and lying of transmission lines. It is further submitted that, the deputy commissioner had not properly carried out the compensation proceeding as prescribed by the law. The deputy commissioner had made an order on **08.07.2014**, bearing order no. MAG (1) CR 250/2014-15, of compensation of 2.25 lakhs for Category A, Rs 2.50 laksh for category B, Rs 3 Laksh for Category C and Rs 4 Lakhs for category D, without considering the due process of law and the proceeding carried for awarding the compensation is not yet informed to the land owners. However the compensation of 2 lakhs is only paid to the land owners.

5. It is submitted that, The Ministry of power to Government of india, had passed the guidelines for payment of compensation towards



damages in regard to Right of way for transmission lines, in its order bearing no. 3/7/201-Trans, dated 15.10.2015. Whereas, principle secretaries/Secretaries ( Energy) of Various states had conducted several meeting which was held on 20.04.2015, 30.04.2015 and 11.05.2015, and finally concluded on 01.06.2015 and recommendations was passed for the guidelines for determining the compensation payable towards Damages as Stipulated in Indian Telegraph act which will be in addition to the compensation towards normal crop and tree damages.

**Recommendations:-**

i. compensation @ 85% of land value as determined by district Magistrate or any other authority based on Circle Rate/ Guideline Value / Stamp act rates for tower base area ( Between Four Legs) impacted severely due to installation of tower/ Pylon Structure.


II. Compensation towards diminution of land value in the width of Row corridor due to laying of transmission line and imposing certain restriction would be decided by the states as per categorization Type of and in different places of states, Subject to maximum of 15% of land value as determined based on Circle rate/ Guideline value / Stamp act Rates.

III. For the purpose, the width of Row corridor shall be at:-

Transmission Voltage	Width of Right of Way ( in Meters)
For 76 K V S/C( With delta Configuration)	64
For 765 K V D/C	67
For 400 K V S/C and 400 K V D/C	46

And shall not be less than the width directly below the conductors.

6. It is submitted that, the officer on special Duty to Minister for energy held minutes of the meeting under the Chairmanship of Sri D K shivakumar, Minister for Energy, government of Karnataka, held on 19.07.2017 at room no. 336 Vidhana soudha, Bangalore on the issue of Execution of Transmission Lines of PGCL in Karnataka, held that the guidance value needs to be enhanced, commensurate with 15 % of the market value/ stamp at rate, however, it should not exceed four times the present guideline value. Based on the order the Deputy Commissioner of Ramangara, Bangalore (urban) and Bangalore



(Rural) had enhanced the compensation by enhancing the market value. Whereas revised order is passed by the Bangalore urban Deputy Commissioner on 09.10.2017 bearing Order no. MAG (4) Mis/CR / 376/2011-12, for enhancement. Similarly the Deputy Commissioner of Chikkaballapura had also passed the revised order dated 23.11.2017 bearing order no. LAQ Cr 10/2017-18 for enhancement.

7. It is submitted that, the deputy commissioner had not followed the order passed by the Ministry of power to Government of India dated 15.10.2015 and government of Karnataka, held on 19.07.2017 in spite of repeated request by the land owners of tumkur district and still insist to pay the earlier compensation order passed on 08.07.2014 and not taken any steps as per the order passed by special Duty to Minister for energy held minutes of the meeting under the Chairmanship of Sri D K shivakumar, Minister for Energy, government of Karnataka, held on 19.07.2017 and Ministry of power to Government of India dated 15.10.2015.

8. It is further submitted that, for 400 KV D/C line land width must be 46 mtrs and for 765 KV Dealt land Width must be 68 mtrs, as per the guidelines. The respondent no. 1 and 2 is not following the said formalities in awarding the compensation and paying compensation only to the extent of 26 mtrs in respect of 400 KV D/C line instead of 46 mtrs and for 36 mtrs in respect of 765 KV Dealt line instead of 68 mtrs. The M/s. Kudgi Transmission Limited and M/s. Power grid NM Transmission Limited are not provided the provided the proper clarity in spite of request by the plaintiff's.

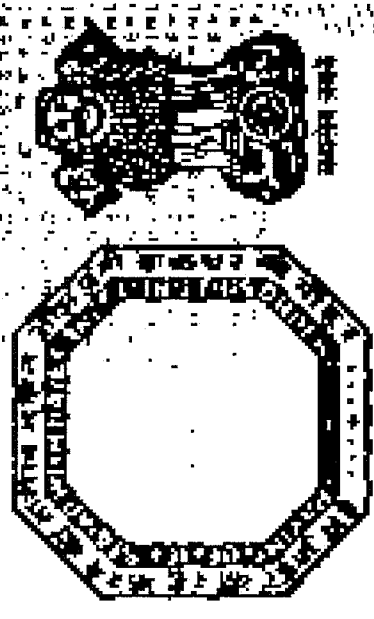
