
This has reference to your RTI request dated 19 March, 2019 for providing information under RTI Act, 2005.

Query No. 1: Kindly furnish the information regarding the amount of Basic customs Duty paid via any mode of payment to Customs Department in FY 2016-2017 & 2017-2018.

Answer: The data regarding Customs duty paid by POWERGRID in financial year 2016-17 and 2017-18 is a published data which is available on www.icegate.gov.in. The required data can be accessed by entering the POWERGRID IEC code: 0591023768 in the above said website.

The total SEIS received for the respective years as under:

2016-17: Rs 32354303.00

2017-18: Rs 32232302.00

The above scrips were utilized towards the payment of Customs duties of POWERGRID.

Query No. 2: Kindly furnish the information regarding the excess GST Input Credit or excess GST Output payable in your monthly returns of GST and the amount of your Input credit accumulated/Output GST paid in monthly.

Answer: The information sought is voluminous in nature and pertains to 36 GST registrations of POWERGRID in every State of India. The collection and compilation of data in the given format from all the States would disproportionately divert the resources of the POWERGRID. Therefore such voluminous information cannot be provided under Section 7(9) in The Right to Information Act, 2005. However, if information is desired for any particular transaction pertaining to any specific registration/State, the same may be provided by POWERGRID.
