As per CEA office memorandum No. 1/9/93-Adm.IV dated 20th December, 1993, The Government of India, Ministry of Power have decided to transfer the five Regional Load Despatch Centres(RLDCs) in a phased manner beginning 31-12-1993 to the Power Grid Corporation of India Limited(POWERGRID) as per the program given below:-

SRLDC, Bangalore on 31-12-1993

ERLDC, Calcutta on 31-12-1994

NERLDC, Shillong on 31-12-1994

NRLDC, New Delhi on 31-12-1995

WRLDC, Bombay on 31-12-1995

Most of the employees working in different RLDC's were opted for absorption in the service of POWERGRID after the technical resignation from Government service of respective REBs under CEA. Further they opted for pensionary benefits (a) Under Central Government rules OR (b) Governed by the rules of the PSU.


