Q 2	It is requested to provide cutoffs for each stage (i.e. GD, Interview and final merit list) for each Department against each category through GATE 2018.	
Reply	The cutoff marks in GATE (normalized out of 100) for being shortlisted for GD and Interview for the post of ET 23 through GATE 2018 have already been informed to all applicants in their respective candidate login accounts. It is also provided in Annexure I. There are no cut off marks in Interview, Group discussion or in final merit list. Candidates are issued offer of appointment in the order of merit prepared on the basis of final marks incorporating marks in GATE, personal interview and group discussion of the qualified candidates and as per category-wise vacancies.
