Reply: Contract personnel on fixed tenure basis are engaged as Field Engineers at site and are generally involved in short term consultancy assignments such as rural electrification (RE)/ distribution management system (DMS)/ sub transmission (ST)/other construction works etc. Field Engineers are generally utilized to assist Engineers (Permanent employees) who are accountable to ensure execution of works in accordance with policy, plans, targets and guidelines.

Executive Trainee and Assistant Engineer Trainee are engaged as trainees and they do not have any specific duties and they are provided training for period of 1 year. They are regularized after successful completion of 1 year training in different functions of POWERGRID.


