

Q 1	How many candidate join for ET Batch 23 through GATE 2018 in each category?
Reply	Joining process for ET 23 rd batch through GATE 2018 is still under progress. Information about number of candidates joined against Unreserved or Reserved Vacancies can only be finalized after completion of the recruitment process.
Q 2	Is there still any waiting list
Reply	There is no such entity as a 'waiting list'. Candidates who qualify in interview are empaneled in order of merit of total marks. Offers of appointment are issued as per vacancies in the respective categories.
Q 3	What is the marks of the last candidate who get selected in SC category out of 100?
Reply	Total Marks(out of 100) obtained by the last candidate selected against vacancy reserved for SC category in ET(Electrical) 23 rd batch through GATE 2018 is 52.78
Q 4	This time can we expect for 2 nd round of interview call letter, if there are unfilled seat or candidate not joined?
Reply	The requested information pertains to a speculation and does not come under the purview of the RTI Act, 2005.
