ORDER

Grounds of Appeal


The Appellate Authority has received an online Appeal bearing number PGCIL/A/2018/60014 dated 16th February, 2019 from Sh. Harsh Tripathi. Shri Tripathi is seeking clarification regarding his candidature, for the post of Assistant Engineer Electrical (Post ID 162). Earlier, the appellant herein had filed an application bearing number PGCIL/R/2019/50032 dated 15th January 2019, with the CPIO Corporate Centre, seeking information regarding aforementioned post.

On receipt of the appeal, information provided to appellant by CPIO vide letter dated 14th February 2019, and relevant papers were perused. CPIO informed that all information regarding the RTI application has been provided to the appellant including the reason for not considering his candidature for the post. The candidature was not found suitable in terms of type of experience required for the post.

Decision

In my considered opinion the appellant herein, wants to know the reason for not being shortlisted for the aforementioned post despite having post qualification experience of one (1) year. I have perused the information provided by CPIO and I am of the view that the as per the mandate of the Act, it is the information which is to be provided to the applicant. It is not incumbent upon the Public Authority to provide reasons under the garb of information. As far as information is concerned the same has already been provided to the appellant vide letter dated 14th February 2019 with reasons though the same was not required and as such no more clarification can be provided.

The Appeal is accordingly disposed of.
