

Q 1	How many Candidates joined ET through GATE 2018 in OBC and General candidate
Reply	Vacancies are not demarcated separately for "General" category. However, 35 candidates have joined against "Unreserved" vacancies. Joining process against vacancies reserved for "OBC(NCL)" is still not completed. Information regarding candidates joined can only be provided after completion of joining process.
Q 2	Last serial rank in OBC and General candidate to issue offer letter
Reply	The last candidate to be issued an offer under "Unreserved" category was at merit Rank : UR - 127 As mentioned in reply to query 1, the Joining process against vacancies reserved for "OBC(NCL)" is still not completed.
Q 3	How many candidates are empaneled in OBC and General candidate
Reply	Number of candidates empaneled under "Unreserved": 127 Number of candidates empaneled under "OBC(NCL)": 112 Please note that candidates empaneled under reserved categories may also be empaneled under Unreserved category if qualified as per the criteria for Unreserved vacancies.
