ORDER

Grounds of Appeal


The Appellate Authority has received an online Appeal bearing number PGCIL/A/2018/60018 dated 25th February, 2019 from Sh. Ritesh Kumar. Earlier, the appellant herein had filed an RTI application-bearing number PGCIL/R/2019/50047 dated 24th January 2019, under RTI Act, 2005 with the CPIO Corporate Centre, POWERGRID seeking transfer policy for non-executives in POWERGRID.

On receipt of the appeal, information provided to appellant by CPIO vide letter dated 25th February 2019, and relevant papers were perused. CPIO informed that there is no documented transfer policy for Non- Executive employees in POWERGRID. However, POWERGRID Employees of all cadres are liable to be transferred during the course of employment to meet operational and administrative requirement of the company.

Decision

I am of the view that the information sought by the appellant herein has already been provided by the CPIO vide letter dated 25th February 2019. It appears that in his appeal the appellant has sought some information, which he did not seek at the time of filing of RTI application. Any information which was not sought vide original RTI application may be requested by filing fresh RTI application with CPIO.

The Appeal is accordingly disposed of.
