

Reply	<p>There are no cut off marks for final selection. Candidates are issued offer of appointment in the order of merit prepared on the basis of final marks incorporating marks in Written test (CBT), personal interview and group discussion and as per category-wise vacancies.</p> <p>As mentioned at reply 1(a) above, the category-wise cut off "ranks" of offers issued have already been made available to all shortlisted candidates at the candidate login accounts.
