

As far as direct procurement of Conductor i.e. HTLS and AL-59 Conductor is concerned, the details such as Name of Contractor, Date of Award, Value of the Contract, Name of the project and other related information can be seen from POWERGRID's official website i.e. <http://www.powergridindia.com/> under the head Tenders

Regarding procurement of the same through Turnkey EPC Contractors executing transmission line works as sub-contracted items, it is informed that at Corporate Centre, large Contracts for various Supply-Cum-Installations, EPC, and Turnkey Contracts are placed by CS Deptt. EPC Contractor usually sources various equipment/items from Sub-Vendors during execution of the contract and the data for such Sub-Vendors is not maintained/recorded in Corporate CS department.
