Already more than 30 days are completed and no response come from the CPIO, so I want to seek this information within 48 hours from the first appellate as few question in the Information sought concerns with the life or liberty of a persons working in the organisation. (e.g since last 10 years the transmission network is expand to 3 times but staff remain almost same is prima facie the condition of over exploitation and human rights violation of government employees, pertains to liberty of a person ) As the Information sought concerns the life or liberty of a person, the same shall be provided within 48 HOURS of the receipt of the request.
