Reply	<p>As mentioned in the advertisement of AETs, graduates who are desirous of pursuing further studies on the basis of GATE 2018 or need extension of joining time in case of selection need not apply.</p> <p>Further, as per terms and conditions of offer of appointment for ET /AET:</p> <p><i>“As the training modules are linked to the whole batch, and not to individual trainees, it will not be possible to give any extension in joining time, irrespective of the reason indicated. It is, therefore, essential for you to report and join on the scheduled date itself, failing which this offer will automatically stand cancelled and withdrawn without any further notice.”</i></p> <p>Hence, any extension in joining time for ETs /AETs is considered on the basis of merit of the case and on organizational requirement.</p>
