# **Grounds for First Appeal:**

This is reference to your reply vide No. PGCIL/R/2019/50170 Dated 24.04.2019 against my RTI request dated 08.04.2019, It has been informed that

There is no such information readily available with the corporation, Creation of such data will disproportionately divert the resources of the corporation, accordingly above information cannot be provided.

The reply of CPIO is very surprising in which basic information about eligible candidates due for promotion from Manager to Chief Manager in CPC 2019 is being denied. The above reply appears to be ridiculous due to following reasons

- 1. PGCIL has a separate HR deptt. setup which is maintaining the data of employees and in present days of technology the information sought in RTI is maintained online by reputed organization like PGCIL but It is being told that it shall divert resources of Corporation.
- 2. RTI act 2005 mandates timely response to citizen's request for Government Information but information is being denied due to minor reasons.

- 3. PGCIL has vast experience of conducting recruitment Exams like Diploma Trainees, Executive Trainees in which thousands of applications are scrutinized. The information sought in this RTI pertains to 250 to 300 employees (approx.) who have worked for 15 to 25 years (approx.). It is being informed that no readily information is available about their higher technical qualification/higher non technical qualification and other details sought in RTI request.
- 4. PGCIL has recently evaluated and promoted candidates from Manager to Chief Manager in CPC 2019 but information is not being given for higher technical qualification/higher non technical qualifications/special recommendations, weight age of candidates in CPC 2019 proceedings.
- The information can be made in few minutes and is not lengthy information, details can also be given in some other suitable format available with PGCIL which covers all the data sought in RTI but information should not be denied on minor reasons.
- 6. Employees are the real assets of the corporation but it is being told that basic information about their qualifications & other details as per CPC 2019 shall divert resources of the corporation if reply is given to RTI.
- 7. The applicant is surprised & shocked to read the contents of letter by CPIO, POWERGRID regarding denial of information. The applicant feels that CPIO, POWERGRID has deliberately used procrastinating tactics and curbed the very purpose of RTI act 2005.

## **Relief Sought**

- To ask CPIO , POWERGRID to supply all the information in sympathetic and generous spirit , Public money is involved in running of PGCIL & It is matter of great public interest that only deserving candidates have been promoted. So it is requested that all details sought in RTI are given at the earliest.
- 2. Any other relief as suitable in interest of justice & equity.


