**ORDER**

**Grounds of Appeal**

The Appellate Authority has received an online Appeal PGCIL/A/2019/60039 dated 10<sup>th</sup> May 2019 from Sh. Pawan Kumar. Earlier, the appellant herein had filed an online RTI application bearing number PGCIL/R/2019/50173, dated 10<sup>th</sup> April 2019, with the CPIO Corporate Centre, POWERGRID, seeking information regarding DPC Exam conducted in the year 2018, for the post of Asst. Manager. The instant appeal has been filed by the appellant on the ground that CPIO has not provided him the information related to all the participants.

On receipt of the appeal, relevant papers and information provided by the CPIO were perused. It was informed by the CPIO that all the information, except the information related to result of all the participants has been provided to the appellant vide its letter dated 7<sup>th</sup> May 2019.



**Decision:**

I am of the view that the information related to DPC exam conducted in the year 2018, has been provided by the CPIO vide its letter dated 7<sup>th</sup> May 2019. The contention of the appellant that the information related to marks of all the participants should be provided to him cannot be acceded to as the same relates to personal information of other candidates, the disclosure of which would not serve any larger public interest. The same is exempted from disclosure under section 8 (1) (j) of the RTI Act, 2005.

The Appeal is accordingly disposed of.
