| 1. | Point No.1 | Attention is invited to DoPT's O.M. No.1/18/2011-IR dated 16.09.2011 which inter-alia, stated that 'only such information can be supplied under the Act which already exists and is held by the public authority or held under the control of the public authority. The public Information Officer is not supposed to create information; or to interpret information; or to solve the problems raised by the applicants; or to furnish replies to hypothetical question'. The same issue has also been elaborated by Hon'ble Supreme Court in the matter of Central Board of Secondary Education & Anr. Vs. AdityaBandopadhyay&Ors. (Civil Appeal No.6454 of 2011) whereby some misconceptions about the RTI Act was clarified as follows: "A public authority is also not required to furnish information which require drawing of inferences and/or making of assumptions. It is also not required to provide 'advice' or 'opinion' to an applicant, nor required to obtain and furnish any 'opinion' or 'advice' to an applicant. The reference to 'opinion' or 'advice in the definition of 'information' in section 2(f) of the Act, only refers to such material available in the records of the public authority. Many public authorities have, as a public relation exercise, provide advice guidance and opinion to the citizens. But that is purely voluntary and should not be confused with any |
