Reference is invited to your RTI application received in PG Desk "Online" through RTI Cell of this Ministry with Registration No. POWER/R/2019/50151 dated 14.03.2019, seeking information under the provisions of RTI Act, 2005 and to say that in so far as PG Desk, MoP is concerned, the information is as under :

Sl. No.	Information sought	Reply(in so far as PG Desk, MoP is concerned.)
1.	Point No.1	<p>Attention is invited to DoPT's O.M. No.1/18/2011-IR dated 16.09.2011 which inter-alia, stated that 'only such information can be supplied under the Act which already exists and is held by the public authority or held under the control of the public authority. The public Information Officer is not supposed to create information; or to interpret information; or to solve the problems raised by the applicants; or to furnish replies to hypothetical question'. The same issue has also been elaborated by Hon'ble Supreme Court in the matter of Central Board of Secondary Education & Anr. Vs. Aditya Bandopadhyay & Ors. (Civil Appeal No.6454 of 2011) whereby some misconceptions about the RTI Act was clarified as follows :</p> <p>".....A public authority is also not required to furnish information which require drawing of inferences and/or making of assumptions. It is also not required to provide 'advice' or 'opinion' to an applicant, nor required to obtain and furnish any 'opinion' or 'advice' to an applicant. The reference to 'opinion' or 'advice in the definition of 'information' in section 2(f) of the Act, only refers to such material available in the records of the public authority. Many public authorities have, as a public relation exercise, provide advice guidance and opinion to the citizens. But that is purely voluntary and should not be confused with any obligation under the RTI Act."</p> <p>In so far as your query is concerned, no such information is available, hence, information may be treated as 'NIL'.</p>
2.	Point No.2	<p>The pay fixation in respect of Below board level executives is dealt in their respective CPSEs. Hence, point No.2 is transferred to PGCIL for furnishing available information to you directly.</p>

I am not asking what should be my basic pay. I need to know what will/should be the MINIMUM REVISED BASIC PAY, who joined ~~after~~ in CPSE after 2017 with a pre-revised basic pay of Rs. 16,000/-.

* Due to personal issue, I am unable to share the name of CPSE

* The revised basic pay will be differed from CPSE to CPSE. But there must be some criteria to fix revised pay.

For Eg.: My basic is 16,000/- + DA (119.5%) of on 01.01.2017

⇒ Revised basic pay should be minimum Rs. 35,120/-

⇒ From CPSE to CPSE, it may vary to any extent. But Rs. 35,120/- should be minimum.

* So now tell sir, what should be my minimum basic after pay revision. (I have joined after 2017 with pre-revised basic of Rs. 16,000/-).

* And also kindly answer for the first question, mentioned in online.
