

Reply	One post of Company Secretary is there in POWERGRID.	
Q2	What is initial cadre of Company Secretary and what is the highest cadre of the Company Secretary?	
Reply	Executives in Company Secretariat function are recruited as Assistant Officer Trainee and regularized after 1 year of training at initial level of E2 (Officer). Currently highest level in company secretariat function is at E8 level (Chief General manger) in POWERGRID.	
Q 3	What is the annual CTC of the initial cadre and highest cadre of Company Secretary?	
	The pay scales for the levels of E2 and E8 are as mentioned below:	
	Level and designation (as per current nomenclature)	Pay scale (IDA)
	E2/ Officer	Rs. 50000-160000
	E8/ Chief GM	Rs. 120000 - 280000
	The pay structure and benefits	are as per DPE guidelines.
Reply	The last conducted recruitment for induction level (E2 Trainee) in Company Secretary discipline vide Advt. No. 04/2016 dated 30 th April 2016, mentioned the compensation package offered for the post as mentioned below (<i>Please note that the level and pay scales mentioned below are pre-revised</i>): "For Post ID 138- Assistant Officer Trainee (Company Secretary), selected candidates	
	will be paid consolidated stipend of Rs. 24500/- per month during one year training. After regularization, they will be placed in the pay scale of E1- INR 20600 – 46500/ The approximate CTC after regularization shall be Rs. 12 lakhs per annum."
