This has reference to your RTI request dated 15 April, 2019 for providing information under RTI Act, 2005.



Reply: The following is the reservation percentage in Promotion SC-15%; ST-7.5%

- b) Kindly furnish the details of agency/panel (internal/external) who is preparing the questions for DPC promotion exam of supervisors.

Reply: The source by which Question Paper is prepared is confidential in nature and disclosure of same would mar the secrecy of examination process. Accordingly the requested information cannot be provided as per clause 8(1) (j) of RTI Act.

- c) Is there any minimum pass mark fixed for the selection process in DPC promotion of supervisors. If yes kindly furnish the details. If no kindly furnish the details of fixing the cut-of mark for passing general reservation category.


Reply: The minimum pass marks fixed for selection process in DPC promotion exam is UR- 50% & Reserved Category - 40%

- d) Kindly furnish the number of vacancies for DPC promotion exam conducted on 2018 Dec for the year 2017 & 2018. If not declared, furnish the reason for not publishing.

Reply: 112 Nos.

- e) Kindly furnish the details of agency/panel (internal/external) which conducted the evaluation of answer sheets of DPC exam 2018.

Reply: The source by which Question Paper is evaluated is confidential in nature and disclosure of same would mar the secrecy of examination process. Accordingly the requested information cannot be provided as per clause 8(1) (j) of RTI Act.



- f) Kindly furnish the details of DPC 2018 exam results of total participants based on marks scored for part A and B separately. If not available kindly furnish reason.

Reply: The above information is related to personal information of 3rd party and does not serve any public interest. Disclosure of such information is exempted u/s 8(1) (e) and 8(1) (j) of the Act.

- g) As per POWERGRID norms is there any time period for publishing the results. If yes furnish the details. If no, is there any delay occurred in publishing the result of DPC Exam 2018. If delay occurred kindly furnish the reason.

Reply: There is no time period for publishing the results and there was no delay.

- h) Kindly furnish the copy of my (60046) evaluated answer sheet written in DPC exam 2018 (including objective type) with marks scored.

Reply: The question paper for DPC examination is actually Question paper cum Answer sheet. These questions cum answer papers are part of our question bank which will be used in future Recruitment/ Promotion Process.

The disclosure of Question Papers under RTI will make it useless for future Recruitment / Promotion Practice. Accordingly, information is denied under section 8 (1) (d) of the RTI Act, 2005.
