The CPC proceedings contains confidential information about other officers which is exempt from disclosure under section 8(1) e and 8(1) j of RTI Act 2005 .

The grounds of appeal are as under

2. It seems that as per view point of CPIO POWERGRID . proceedings of CPC 2019 does not come under the preview of RTI Act. 2005 which is not true & common citizens have the right to know about govt. functioning
3. PGCIL has a vast HR deptt setup which and promoted officials recently in CPC 2019.
4. RTI act 2005 gives the mandate for timely response to citizen's request for Government Information but information is being denied due to minor reasons.
5. The number of replies has been given in past of similar nature but now various objections are being raised for this information. CPIO , POWERGRID has given information about interview marks, total marks in case of various recruitments done in past . The details is as under

back & now objections are being raised on 21.05.2019 & useful time is being wasted . It should be clarified whether there is change in RTI rules after 01.04.2019

Relief Required :



But even if your good self feels that personals details of employees is exempt under section 8 (1) e and 8(1) j of RTI Act , It is requested that information about all employees **region wise** is given in this revised format so that name and employee no of candidates are not disclosed & below mentioned details are given strictly according to below mentioned format for all the candidates due for promotion in CPC 2019 from MGR. to CHIEF MANAGER whether promoted or not promoted.


