This has reference to your RTI request dated 3 May, 2019 for providing information under RTI Act, 2005.



Reply to RTI Query by Sh. Pankaj Verma

Query	In POWERGRID's Vigilance team, how many employees have joined on Deputation during 2000-2018 who were Constable in Union Territory/ Police/ State Police/ Paramilitary Forces.
Reply	As per the records available (though no such data is available in compiled form), no person who was a Constable in Union Territory/ Police/ State Police/ Paramilitary Forces joined POWERGRID Vigilance department on deputation during 2000-2018.
Query	During 2000-2018, every year how many employees of Uttarakhand/ Delhi/ Maharastra/ UP Police have joined on deputation.....(<i>Question not clearly readable</i>)
Reply	As per records (though no such data is available in compiled form) - Nil
Query	Whether personnel joining on deputation in POWERGRID gets permanently absorbed in POWERGRID?
Reply	There is no provision for automatic permanent absorption of personnel coming on deputation to POWERGRID.
