

Query	<p>I am AnandKumar Shukla....Please give me complete reply of my following points:-</p> <ol style="list-style-type: none">1. My first region of preferences in interview is NR-III, but after successful qualified in interview, the region of posting allotted is NR-II, as I was many times request to HR personnel through mail and personally for change of my region of posting from NR-II to NR-III at least during starting years of my joining. , on humanitarian ground because my father I suffering from severe health issues (Paralysis). But on 16.04.2019, my offer of appointment is cancelled through mail and issue to waitlist candidate got first choice of posting in NR-III, then why my request was not consider.2. Secondly, my duty is in Lok Sabha election-2019 on dtd. 29.04.2019 as per order from office of District Collector, Jabalpur, I was send all the orders regarding election training and 29.04.2019 duty order through mail on dtd. 11.04.2019 to the HR, POWERGRID, but the request of extension of joining was not consider on this important govt. duty.
Reply	<ol style="list-style-type: none">1. Posting of candidates selected for the post of Dy. Manager (Electrical) was allotted based on Requirement of manpower in various regions/locations in India, Performance of candidate in Interview & Region preference submitted by candidates. Region preference in itself was not the sole decider for place of posting. Against cancellation of your offer for NR-II, substitute offer was issued for NR-II only.2. As per offer letter issued to you, your scheduled date of joining was 15.03.2019. However, based on your request and pending deptt. formalities at your end, extension for 01 month i.e. 15.04.2019 was given to you for joining. The extended date was accepted by you and acknowledgement of resignation was submitted by you mentioning your date of separation as 30th March 2019. As the requirement of manpower was urgent and immediate, no further time extension could be given.
