
The Appellate Authority has received an online Appeal bearing number PGCIL/A/2019/60049 dated 11<sup>th</sup> July 2019 from Sh. Jugal Kumar. Earlier, the appellant herein had filed an online RTI application bearing number PGCIL/R/2019/50220, dated 27<sup>th</sup> May 2019, with the CPIO Corporate Centre POWERGRID, seeking information related to candidates due for promotion from E5 to E6 (Manager to Chief Manager). The instant appeal has been filed by the appellant on the ground that CPIO has not provided the requisite information to him.

**Decision:**

On receipt of the appeal, relevant papers and information provided by the CPIO vide letter dated 12<sup>th</sup> June 2019 were perused. It can be noticed that the CPIO has provided the information as was available with him in pursuance to the queries raised by the appellant in his RTI application. The contention of the appellant that the information provided is not requisite is unfounded as the

appellant in his appeal is trying to seek information after analyzing the information provided to him, the same is not the mandate of the Act. As far as information related to third party is concerned CPIO is right in denying the same in view of the exemptions envisaged under 8(1) (j) of the Act.

The appeal is accordingly, disposed of.
