This has reference to your RTI request dated 28 May, 2019 for providing information under RTI Act, 2005.



Reply: AAR dossier for supervisors is not maintained by us, accordingly the same is not provided.

4. Copy and details of report of DPC findings of my interview on 9th May, 2019 at CC.

Reply: DPC findings are contained in evaluation sheet and the same is a confidential document which cannot be provided. The same is exempted under clause 8(1) (j) of the Act.

5. Copy of the evaluated answer sheet of my DPC 2018 exam. (Questions are not mandatory).

Reply: The question paper for DPC examination is actually Question paper cum Answer sheet. These questions cum answer papers are part of our question bank which will be used in future Recruitment/ Promotion Process. The disclosure of Question Papers under RTI will make it useless for future Recruitment/ Promotion Practice. Accordingly, information is denied under section 8 (1) (d) of the RTI Act, 2005

6. Copy of rank list/merit list of candidates before and after interview in separate list for general and reserve category on all India basis.

Reply: As per practice no Rank list or Merit list is prepared. The qualifying marks in AAR, written test and interview are 50% for UR & 40% for reserved category candidate. The candidate is promoted based on above marks.

7. Copy of POWERGRID guidelines of criterias to be examined in interview/viva voce of DPC scheme of S4 to executive.

Reply: DPC- take into consideration, the education qualification, experience profile, AAR rating, performance in the written test and interview and makes the final recommendation.

8. Details of marks scored by me as during interview/viva voce in each criteria of query no.7.

Reply: Answer already replied to in question no.1

9. Copy of document declaring the vacancies for the DPC 2018. If not declared furnish the information for not declaring.

Reply: The total vacancies for promotion from S4/SG to E2 in various disciplines were 112 nos.

10. The marks for AAR and grade seniority as per promotion policy is part of interview or evaluation process.

Reply: The marks for AAR and grade seniority as per promotion policy is part of evaluation process

11. POWERGRID Promotion Policy for Supervisors from S4 to Executive level is in line with an earlier verdict of Hon. Supreme Court (In Sh. Ashok Kumar Yadav Vs. State of Haryana, (1985) 4 SCC 417) or not.

Reply: No information related to above is available in POWERGRID.
