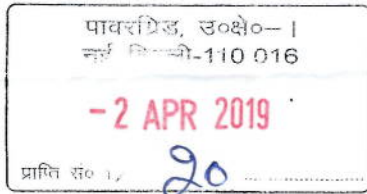

  - iv) Give the name of suppliers with the quantum of supply has been executed to the corporation against the NIT publication along with the nature of items rendered. Give detail.
  - v) Give the name and designation of the officer, who had received the material from the suppliers by assigning on the bills/invoice /challan. Give detail.
