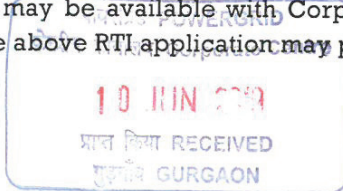
**Quote from Chapter II page 5, RTI Act 2005**
