Sir,

This is reference to your reply vide No. PGCIL/R/2019/50294 Dated 26.07.2019 against my RTI request dated 28.06.2019, It has been informed that

The reply of CPIO is very surprising in which basic information about eligible candidates due for promotion from Manager to Chief Manager in CPC 2019 is being denied. The preliminary objections to above reply is as under

1. ***The information was earlier denied for similar nature RTI available in RTI section of PGCIL website and it was informed at first stage that There is no such information readily available with the corporation, Creation of such data will disproportionately divert the resources of the corporation, accordingly above information cannot be provided***
2. It was informed that 13 candidates were promoted to Chief Manager without having the basic qualification of Degree in Engg. It is to be noted that as per policy of PGCIL candidates should have minimum qualification of Degree in Engg. & Deptt. Exam is to be held but no written test was held.
3. List of 221 candidates was provided having qualifications of Degree in Engg. & out of which few are having qualifications from those institutes which are not recognized by Honorable Supreme Court Judgment. The candidate's degree has been suspended till the test held by AICTE-UGC is cleared.

4. It is being presumed that only few candidates may have cleared test held by AICTE-UGC 2018 but they were not eligible as on cut off date of 31.12.2018 & their qualifications have been wrongly evaluated. So the date provided for 221 candidates having qualification of Degree in Engg as on cut off date of 31.12.2018 is not correct to some extent .
5. The original RTI application was changed by CPIO , PGCIL in order to delay the information by raising objections as it was clearly written in the RTI application that no third party information is reqd .(Copy enclosed)The same is as under

The following information as desired in Sl. No. 1 to 10 is required under RTI Act 2005 , It should be noted that if any name & employee no. of candidates due for promotion or officials who have done evaluation is coming in information desired from Sl. No.1 to 10 same is redacted (i.e. Personal details like name & employee no. is not disclosed at any stage and is removed) so that Section 8(1) J & 8(1) E of RTI act is not violated at any stage .

The above para was already written on the original application so that information could be easily provided but this was omitted in the RTI reply and information has now been denied by raising objections. CPIO , PGCIL has delayed the information for three months without any reason i.e 30 Days for Appeal & 45 Days time for reply.

6. Public money & share holders' money is involved in running of PGCIL & It is matter of **great public interest** that only deserving candidates are promoted.
7. The reply for para 1 was equally surprising as it was told that no RANK/ Merit list has been prepared, CPIO , PGCIL of NAVRATNA company is denying information on **simple math calculation** . It is simple math calculation that candidate having high marks is having higher rank . But the information **can be provided without Rank or Merit position** & It is requested that other information sought in para 1 are given at earliest .

Relief Required

Para 1:-

It was informed that

No Rank List or Merit List is prepared. Therefore above list can not be Drawn .

The Para 6.6 of PGCIL promotion policy states that

The marks secured by each eligible executives from the Performance Appraisal Reports, Grade Service and mark awarded by CPC (wherever applicable) will be aggregated in the evaluation sheet. Those executives who have been found suitable for promotion will be ranked in order of merit. Where aggregate of marks is the same, they will be ranked in order of seniority. The promotion order shall be issued in respect of executives who secure the promotability marks.

Taking into view above facts your goodself can judge how information is being denied due to minor reasons & even promotion policy is not being implemented .

As per promotion policy of PGCIL , Ranking is to be maintained but if even if ranking has not been maintained. It is alright and all the other desired information in Para 1 is given.

Para 2 to 10 –

It has already been requested in my original RTI application that

if any name & employee no. of candidates due for promotion or officials who have done evaluation is coming in information desired from Para No. 1 to 10 same is redacted (i.e. Personal details like name & employee no. is not disclosed at any stage and is removed) so that Section 8(1) J & 8(1) E of RTI act is not violated at any stage .

The same is already clear that there are no of discrepancies/mistakes in promotion process as told in Sl. No. 1 to 4 due to which desired information is being denied. As no name is being disclosed , It is clear that same would not cause unwarranted invasion in the privacy of individual . **It is now 100 percent clear that no name of candidate & officials is to be disclosed so Section 8(1) J & 8(1) E of RTI act is not violated at any stage. So it is requested to your goodself to issue directions to CPIO, PGCIL that necessary that desired information is given at earliest.**


