## **ORDER**

## **Grounds of Appeal**

The Appellate Authority has received an online Appeal bearing number PGCIL/A/2019/60060 dated 14<sup>th</sup> August 2019 from Sh. Ravi Prakash. Earlier, Sh. Ravi Prakash had filed an online RTI application bearing number PGCIL/R/2019/50328, dated 13<sup>th</sup> July 2019, with the CPIO Corporate Centre POWERGRID, seeking information related to VIP requests for Transfer of Employees. The instant appeal has been filed by the appellant on the ground that CPIO has provided incomplete information to him.

## Decision:

On receipt of the appeal, relevant papers and information provided by the CPIO vide letter dated 13<sup>th</sup> August 2019 were perused. It can be noticed that the CPIO has provided the information as was available with him in pursuance to the queries raised by the appellant in his RTI application. The contention of the appellant that information related to **VIP requests for transfer of manpower** has not been provided is not right, as the same has specifically been provided in the

letter dated 13<sup>th</sup> August 2019, wherein it is categorically mentioned that such cases are dealt on merit and no data is being maintained as such.

The appeal is accordingly, disposed of.
