In point number 1.A, 2.E and 3.A, number of offer letter issued is been asked. It is obvious that any company will issue offer letter against the vacancies. In first phase as many offer letter were issued as number of vacancies. Subsequently, more offer letter were issued against candidates did not joined in the first phase. Kindly provide the information about the **total number of offer letter issued including those candidates who did not join the company, post wise.**

In point number 1.E and 3.E information asked was about payment to GATE organizing committee for using GATE score for the recruitment through GATE 2017 and GATE 2016 respectively, **including TAX.** Kindly provide the information **including TAX.**

For point number 1.F, 2.L and 3F no information has been provided. Kindly provide the information about cost of advertisement (**including tax**) for point number 1.F 2L and 3.F as well.

In point number 1.G and 2.M, information asked was **TOTAL FEE** collection from candidates for application for Executive Trainee and Assistant Engineer Trainee respectively. Application fee per candidates is indicated in the advertisement. Kindly provide the information about **total fee collection** for application for the post of Executive Trainee and Assistant Engineer Trainee recruited through GATE 2017 separately.

For point number 1.H, 2.N and 3H, no information has been provided.

Amount paid to candidates as Travel Allowance for attending interview was in Lakhs. Number of candidates appeared for interview for the post of ET recruitment through GATE 2017 was 441 (258+57+75+51=441). Travel allowance paid to Candidates was for AC class by train. Considering minimum amount of ₹1000 per side per candidates (from home town to interview one side) paid to candidates, sum total of travel allowance paid to candidates for appearing in interview for recruitment through GATE 2017 would be ₹ 8,82,000(441x2x1000) approx.. And Travel allowance claim recodes are maintained by company finance department for audit and vigilance purpose. This is huge amount and cannot be ignored. This amount can't be paid from petty cash fund and accountable. Hence I request you to provide the information for 1.H 2.N and 3.H from finance department.
