2	Providing of Guest House Accommodation to Shri M.S. Subrahmanyam, IAAS, O/o PDCA&MAB from 20.04.2019 to 13.06.2019 for four members in Room No.2 & 3. Details required for the cost of accommodation and food borne by POWERGRID.	Shri M.S. Subrahmanyam, DGCA, O/O Director General of Commercial Audit, Hyderabad was treated as Company Guest with approval of Competent Authority and hence no charges are applicable for accommodation and food as per the rules of the Corporation.
3(a)	Sanction of 100% HRA to Shri A. Radhakrishna, CM, HR and his wife Smt. A. Nirmala, ES deviating from the HRA Sanction Rules. Please furnish why the deviation of HRA for these persons.	No deviation. Both Shri A. Radhakrishna and Smt. A. Nirmala were eligible for HRA and were sanctioned as per HRA Rules of the Corporation.
