1.1 The Department of Public Enterprises under Ministry of Heavy Industries and Public Enterprises, vide its Office Memorandum No: W-02/0028/2017-DPE(WC)-GL-XIII/17, dated: 03-08-2017 had issues orders for "Pay Revision of Board level and below Board level Executives and Non-Unionised Supervisors of Central Public Sector Enterprises (CPSEs) w.e.f 01-01-2017". Information may please be provided whether this office memorandum has been superseded by a subsequent communication of any Ministry of the Government of India.

1.2 Is it true that in compliance of Para # 18 of above cited O.M. dated: 03-08-2017, the administrative ministry of each CPSE was supposed to issue Presidential Directives to each CPSE separately? Also please inform whether such Presidential Directives are issued with the approval of H.E. President of India, else why are the directives termed as "Presidential Directives".

1.3 Is it true that the Ministry of Power, Government of India has issued Order No: 46/8/2017-RE, dated: 28-01-2019 to REC Limited and PFC Limited and has directed them to strictly follow the Presidential Directives mandating only one designation within E8 grade of employees and not allowing inter-se promotions within the same pay scale?

1.4 Have the Presidential Directives been issued by the Ministry of Power, GoI to NTPC Limited, which is a CPSE under the Ministry of Power. If yes, then a copy of such communication may kindly be made available to me by E-mail.

If yes, the name and designation of the authority granting this exemption may please be informed.

4. That I am a citizen of India and I am requesting the information as "Citizen of India"


5. To the best of my knowledge, the above requested information does not relate to section 8 & 9 of the Act, which are exempted from disclosure.
