



6.	<b>Grounds of Appeal</b>	<ol style="list-style-type: none"><li>1. The denial of information by CPIO is an arbitrary decision and hence illegal;</li><li>2. The information requested by the Appellant are very specific and related to particular tender for which the tender process is completed and successful bidder has been selected;</li></ol>



CPIO has not specifically demonstrated how disclosure of information would result in violation of commercial confidence and may impact competitive position of PGCIL for future projects consequently a violation of section 8(1)(d) of the RTI Act, 2005;</p> <p>4. CPIO has not specifically demonstrated how sharing of information sought by the applicant may jeopardize PGCIL interest which may result in loss of business through TBCB route to PGCIL and consequently a violation of section 8(1)(d) of the RTI Act, 2005;</p> <p>5. CPIO has not specifically demonstrated how disclosure of information and documents requested by the applicant contain information which is of commercial confidence and there is no obvious public interest that warrants the disclosure of such information and consequently violation of section 8(1)(d) of the RTI Act, 2005. As per provision of section 8(1)(d) of the RTI Act, 2005, the authority may refuse to give information relating to commercial confidence, trade secret or intellectual property, disclosure of which would harm the competitive position of a third party, unless the competent authority is satisfied that larger public interest warrants the disclosure of such information. In this reference in the present case, the tariff charged by PGCIL for the development, operation and maintenance of the above mentioned transmission system will have direct implication on the customers of the transmission system such as state distribution companies. Such customers, being distribution companies are supported by state / central government funds, the source of which is mostly the taxpayer's money. Further, the tariffs will be passed on by these distribution companies on the end consumers who consume electricity which is general public at large. The rationale adopted for charging the general public is thus, a matter of public interest to clearly establish that PGCIL, a public sector undertaking is not charging tariffs at an unreasonably high required returns and thus plundering the nation;</p> <p>6. The information requested by the Appellant is falling under the definition of information provided</p>

	<p>under Section 2(f) and related to larger public interest and the disclosure of information shall bring transparency in business affairs of PGCIL and bring accountability of PGCIL;</p> <ol style="list-style-type: none"><li>7. Once a decision is taken in the matter of grant of tender and successful bidder has been selected, there is no justification to keep it secret and the citizen has a right to know the basis on which the decision has been taken by the public authority;</li><li>8. The information requested is project specific for which the bidding process is concluded and successful bidder has been selected. The disclosure of project specific information for which successful bidder has been selected and will not jeopardize the competitive position of PGCIL or interest or result in loss of business;</li><li>9. If PGCIL, being a public authority refuse to disclose the document, the very purpose of the RTI Act will be frustrated;</li><li>10. A citizen has a right to know the genuineness of a document submitted by the tenderer in the matter of grant of tender for development and maintenance of transmission system or for any other work for which the tender process is completed and the successful bidder has been selected, therefore, it will not influence the contract. In any view of the matter, the document in question cannot be treated as trade secret or commercial confidence;</li><li>11. The Appellant also submits that it is a settled law that the onus is upon the public authority to show as to how disclosure of information and documents requested by the applicant contain information which is of commercial confidence and there is no obvious public interest that warrants the disclosure of such information. A mere replication of the words of Section 8(1)(d) would not suffice. The applicant relies upon the judgments of Hon'ble High Court of Jharkhand in State of Jharkhand and Anr. Vs. Navin Kumar Sinha and Anr. (MANU/JH/0328/2007);</li><li>12. The Appellant requests your good office to set aside the decision of the CPIO and direct the said CPIO to disclose all information specified in the instant RTI application and present appeal and honour the</li></ol>



In regard to Tariff Based Competitive Bidding (TBCB) kind of Projects, it is to state that the information in regard of Request for Proposal (RFP) under TBCB Projects warrants confidentiality as they are of commercial confidence in nature and may impact competitive position of POWERGRID for future projects. Therefore, sharing of information sought by applicant may jeopardize POWERGRID interest which may result in loss of business through TBCB Route to POWERGRID.

In view of the above, the information pertaining to Projects cannot be furnished.
