Sub.: Reply of RTI Request received from Shri Dharmendra Pratap.

Information Sought: (i)	How many candidates have been selected in PSU (Public Sector Units) for the last 2 years so far in the BL-Both Leg Handicap category with only two legs in Electrical Engineering field?
Reply (i)	The PwD sub-category of Locomotor Disability – Both Legs affected has not been identified suitable for any post in Electrical Discipline in POWERGRID.
Information Sought: (ii)	How many candidates have been selected in PSU (public sector units) for the last 2 years so far in the OL-One Leg Handicap category with one leg, a subclass of Physical Disability in the field of Electrical Engineering?
Reply (ii)	Since 2017 till date 5 candidates with PwD subcategory of “Locomotor Disability-One leg affected” have been appointed in Executive positions in Electrical discipline. Data regarding regional recruitment may be sought from regions.
Information Sought: (iii)	From the last 2 years till now, in all the engineering field vacancies of the Central Government, how many candidates have been selected for Divyang with one foot and how many candidates from both legs, please clarify the details of both sub-category candidates separately.
Reply (iii)	There is no PwD Subcategory as “one foot”. In the past 2 years, no candidate with “Locomotor Disability – Both Legs” subcategory of disability have been selected for Executive level positions in Engineering disciplines. It may be noted that for Group A posts in Engineering LD - Both Legs subcategory has been identified suitable for only Computer Science discipline. Data regarding regional recruitment may be sought from regions.
Information Sought: (iv)	In the field of Electrical Engineering from the year 2017 to 2019, how many two-legged handicap candidates and how many one-legged handicap students have been selected on the basis of GATE, please explain different details of sub-category?
Reply (iv)	Since 2017 till date, 5 candidates with PwD subcategory of “Locomotor Disability- One leg affected” have been selected through GATE in Electrical discipline.
Information Sought: (v)	Why in all government vacancies only one footed OL (One Leg Handicap) candidate is given more preference than both leg handicapped (BL-Both Leg Handicap) candidate while both are covered under orthopaedic handicap?
Information Sought: (vi)	Why the vacancies of OH-Orthopaedic Handicap category are filled only by One leg handicap candidates in all government recruitments. Why are both leg handicap candidates not eligible while both of them are under the sub-category orthopaedic handicap category? Please clarify?
Reply (v) & (vi)	POWERGRID has implemented reservation policy in line with GOI guidelines & notifications. The list of posts has been identified for in line with provisions of RPwD Act, 2016. No discrimination is made in implementation of the reservation policy.
