In connection with the said petition at Supreme Court and the divorce petition filed by Mr Ashish Agrawal at Mathura, you are requested to please provide me following information under RTI Act, 2005 in the interest of life and liberty of myself and my small son-
  - (i) What is the present Office Address of Mr Ashish Agrawal. Please provide the complete address.
  - (ii) What is the present Residential Address of Mr Ashish Agrawal. Please provide the complete address.
  - (iii) Certified copy of the Salary slips of Ashish Agrawal for the month of March 2018, April 2018, March 2019, April 2019, August 2019.
  - (iv) Certified copy of the latest Immovable Property Return filed by Mr Ashish Agrawal
- 2. Please note that **the information requested pertains to my and my son's life** and is required to be produced before Hon'ble Supreme Court in the next hearings. The disclosure of information sought is therefore in larger public interest.

- 3. Please note that I am the legally married wife of Mr Ashish Agrawal and am entitled to the information requested above. Reliance is placed on the following judgements of Central Information Commission of India-
  - (a) Decision No.3774/IC(A)/2009 in which Hon'ble CIC has held

A faster resolution of marital dispute is always in the public interest. Since the appellant is legally married, with a child, and has asked for details about her husband, there is no justification for withholding any part of information to the appellant, as it would assist in resolving the issue by the competent authority. As long as the couple is not legally separated, refusal to share information which commonly belongs to them is untenable. In a situation like this, when the couple is unable to live together, for the reasons best known to them, withholding of any part of personal or official information about them from each other would harm the interest of the society, particularly their girl child. 8.

The CPIO is, therefore, directed to furnish the information asked for by the appellant on the basis of available records. The appellant would also be free to inspect the relevant documents to satisfy herself with the availability of required information.

(b) Decision No. CIC/AD/A/09/00366 in which Hon'ble CIC has held

Based on the submission put forth by the Appellant, the Commission holds that information being sought is not third party information since the Appellant is seeking information about her legally wedded husband and also because both the Appellant and her spouse had given the names of the spouses for inclusion in their passports .... The Commission, accordingly, directs the CPIO to provide all the available information including all supporting documents to the Appellant...

- 4. Please note that in respect of a similar RTI application filed by me in the past in 2014, I was provided the information in respect of Mr Ashish Agrawal by PGCIL, NR-I, B-9, Kutub Institutional Area, Katwaria Sarai, New Delhi vide letter dated 25-08-2014.
- 5. I am a citizen of India and am entitled for the information requested. Payment of Rs 10 as RTI application fee has already been made by me through online payment. It is also submitted that the above information pertains to your office and is held by you in your statutory capacity as CPIO under section 5(1) of RTI act read with 5(4) and 5(5) of RTI Act 2005. Copy of the marriage certificate is also enclosed for your kind information.
- 6. In view of all the above facts and circumstances, I humbly request you to please provide me the above asked information within 48 hours of the receipt of this application in larger public interest. Further by the time the information is delivered to me by post, properly
