**ORDER**

**Grounds of Appeal**

The Appellate Authority has received an online Appeal bearing number PGCIL/A/2019/60080 dated 5<sup>th</sup> November 2019, from Sh. Vijay Kumar. Earlier, the appellant herein had filed an online RTI application bearing number PGCIL/R/2019/50400, dated 10<sup>th</sup> September 2019, with the CPIO Corporate Centre, seeking information related to candidates who were due for promotion from grade E5 to E 6. The instant appeal has been filed by the appellant on the ground that CPIO has not provided the requisite information to him.

**Decision**

On receipt of the appeal, relevant papers and information provided by the CPIO vide letter dated 9<sup>th</sup> October 2019 were perused. It can be seen that the information sought by the appellant is voluminous in nature and not readily available in the format as sought by the applicant. Collation of such information would disproportionately divert the resources of the corporation. In my opinion

justice would be done if the appellant is allowed to visit POWERGRID office for seeking the information desired by him, with prior appointment (30 days advance notice) with DGM (HR) at contact no. 0124-2822558. However, information related to a particular executive will be furnished subject to his/her consent and just exceptions under RTI.

The appeal is accordingly, disposed of.
