**Sub: - First Appeal against CPIO reply dated 06.09.2019 against RTI request PGCIL/R/2019/50354
Dated 06.08.2019**

Sir,

This is reference to your reply vide No. PGCIL/R/2019/50354 Dated 06.09.2019 against my RTI request dated 06.08.2019, It has been informed that

The reply of CPIO is very surprising in which basic information about eligible candidates due for promotion from Manager to Chief Manager in CPC 2019 is being denied. The preliminary objections to above reply is as under

1. The information was earlier denied for similar nature RTI available in RTI section of PGCIL website and it was informed at first stage that

(a)There is no such information readily available with the corporation, Creation of such data will disproportionately divert the resources of the corporation, accordingly above information cannot be provided.

(b) No Rank/Merit List has been maintained.

(c) Applicant is being informed to visit personally in head office during appeal for taking minor information which can be sent easily by e mail.

(d) It was informed by RTI applicant that no personal details are reqd. but even then it is being informed that Section 8(1) J & 8(1) E of RTI act is being violated.

2. It was later informed that 13 candidates were promoted to Chief Manager without having the basic qualification of Degree in Engg. It is to be noted that as per policy of PGCIL candidates

should have minimum qualification of Degree in Engg. & Deptt. Exam is to be held but no written test was held.

Now It is being informed in this rti reply that

In this regard, it is informed that information sought is voluminous in nature and not readily available with the corporation, it may also be pertinent to mention that some of the information is related to third party and disclosure would not serve any public interest , Accordingly information sought cannot be provided.

- 3. All the tricks are being applied to deny information which is giving rise to suspicion, I hope that this is not the case and all promotions are in transparent manner.*
- 4. Public money & share holders' money is involved in running of PGCIL & It is matter of **great public interest** that only deserving candidates are promoted.*
- 5. The information of only paras as per details given below is given & remaining information can be denied so that there is no wastage of precious time of public authority.*

Relief Required

Para 7 & 8

This information has been asked in such a way that no personal information of any candidate is being disclosed. It is the main objection of CPIO , PGCIL that personal information cannot be given, Now formation has been sought in such a way that no personal information is disclosed . Data of 13 candidates is readily available and can be easily given in **few minutes. But in spite of that objections are being raised in one way or another.**

Para 10 :-

Similar type of information has already been given for promotion from Manager to Chief Manager, Now same can be given for promotion from Dy. Manager to Manager .

Para 12

It is a one line information and requires only one minute of public authority , no personal information is being asked.

Para 20

Personal details like name & employee no. & any other details considered necessary by CPIO , PGCIL is to be removed & any other just able exemption decided by your goodself

Para 29

It is the main objection of CPIO , PGCIL that personal information cannot be given , Now This information has been asked in such a way that no personal information of any candidate is being disclosed. The information is readily available with the PGCIL as per sample formation enclosed. The information is to be given just by removing name and employee number of candidate.

The details are available with PGCIL as per sample format . **Copy of sample format is also being attached for your ready reference & as a proof that details are available with PGCIL.**

So it is requested to your goodself that information sought is given at the earliest by return mail. It is also requested that it is minor information and all data is readily available with PGCIL and information can be easily prepared in 30 minutes easily & It is also requested that please don't ask me to come to your head office for such a minor information as it is wastage of my precious time & money.
