Subject: Prior approval of the Government under Section 68 of the Electricity Act, 2003 for Common System associated with Coastal Energen Private Ltd. and Ind-Barath Power (Madras) Limited LTOA generation projects in Tuticorin Area - Part-B.

Sir,

I am directed to refer to PGCIL's letter No. C/CP/LTOA-Tuticorin B dated 4.6.2010 on the above subject and to convey the prior approval of the Central Government under sub-section (1) of Section 68 of the Electricity Act, 2003 to Common System associated with Coastal Energen Private Ltd. and Ind-Barath Power (Madras) Limited LTOA generation projects in Tuticorin Area - Part-B with following scope of work:

- Establishment of 765 kV Salem Pooling Station (initially charged at 400 kV).
- Tuticorin Pooling Station - Salem Pooling Station 765 kV D/C line (initially charged at 400 kV).
- Salem Pooling Station - Salem 400 kV D/C (quad) line.
- Salem Pooling Station - Madhugiri Pooling Station 765 kV S/C line (initially charged at 400 kV).


The PGCIL may implement the above scheme matching with progress of associated IPP projects.

The approval is subject to compliance of (a) the requirement of the relevant provisions of the Electricity Act, 2003, as amended from time to time and the rules and regulations framed there under and (b) the rules governing the overhead lines as specified in the Indian Electricity Rules, 1956 till they are substituted by corresponding rules framed under the Electricity Act, 2003.

This approval is also subject to the following conditions:

- The implementing agency will commence construction of the project within 3 years, unless this term is extended by the Ministry of Power.
- Ministry of Power may withdraw the approval before the expiry of the period of 3 years after giving a one-month notice.
