REGARDINGS- HT AND LT LINE POLE SHIFTING.

- What should be the actual distance of HT and LT from the house according to the INDIAN ELECTRICITY RULES, 1956.
- 2) Please tell the procedure of the pole shifting and underground of HT and LT line from the house.
- If the distance of HT and LT line is less according to the INDIAN ELECTRICITY RULES, 1956 then who
 is responsible for it.
- 4) If the application is given by the consumer for shifting the poles of HT and LT lines, then how much time will be taken or required by the electricity department for making the estimate.
- 5) If the application is given by the consumer in the month of December 2018 for shifting the poles of HT and LT and estimate is passed in the month of august 2019, then which year rates should be taken or charged by the electricity department from the consumer.
- in which cases the underground LT and HT lines estimates are passed by the electricity department.
- 7) If the distance of HT and LT line is only 2.5ft from the house, then what steps should the consumer take to make appropriate distance of line from his house.
- 8) Which officials of electricity department should be contacted by the consumer for shifting of the HT and LT lines. Does JUNIOR ENGINEER and SUB DIVISIONAL OFFICER of electricity department of particular area has power and rights for shifting of HT and LT lines.
- 9) If the accident occurs due to the less distance of the HT and LT the house then who is responsible for it.
- 10) If the space is available for shifting of the HT and LT poles in front of house, then it is mandatory or compulsory that electricity department willpass underground estimate of HT and LT line for the consumer.


