ORDER

Grounds of Appeal

The Appellate Authority has received a postal Appeal on 14th November 2019 from Sh. Liyit Panor. Earlier, the appellant herein had filed an application dated 16th Sept'19 received on 3rd October 2019, under RTI Act, 2005 with the CPIO Corporate Centre, POWERGRID seeking various information regarding Comprehensive Scheme of Transmission and distribution system in Arunachal Pradesh.

On receipt of the Appeal, relevant papers and information provided by the CPIO vide letter dated 1st November 2019, to Appellant were perused.

Decision

It can be noticed that the CPIO has provided the information as was available with him in pursuance to the queries raised by the appellant in his RTI application. It can be seen that the information sought by the appellant relates to various third parties therefore, as per section 11(1) of the Act, submissions of the parties were invited regarding whether the information related to them should be
