Q.1. Who conducts auction of vehicles which has been condemned or are certified not fit for use, used by Powergrid corporation of India ltd, joint ventures, subsidiaries and other offices.

Ans. Power grid does not conduct auction of vehicles for sale of vehicles which are condemned or which are not fit for use.

Q 2. What is the procedure adopted by Powergrid corporation of India ltd, joint ventures, subsidiaries and other office to conduct auction of condemned vehicles/vehicles which are certified not fit for use.

Ans. Power grid does not conduct auction of vehicles for sale of vehicles which are condemned or which are not fit for use.

Q 3. Is there any rules, acts, regulations or governmental orders governing the mode and method in conducting auction of condemned vehicles/vehicles which are certified not fit for use by Powergrid corporation of India ltd, joint ventures, subsidiaries and other offices.

Ans. Power grid does not conduct auction of vehicles for sale of vehicles which are condemned or which are not fit for use.

Q 4. What is the total fee that I need to pay in order to get a copy of rules, acts, regulations or government orders governing the mode and method in conducting auction of condemned vehicles/vehicles which are certified not fit for use by Powergrid corporation of India led, joint ventures subsidiaries and other offices.

Ans. Power grid does not conduct auction of vehicles for sale of vehicles which are condemned or which are not fit for use.

Q 5. What is the criteria for determining maximum life of a vehicle used by Powergrid corporation of India ltd, joint ventures subsidiaries and other offices.

Ans. A vehicle shall be considered as unserviceable and be recommended for disposal, if any one or more of the following conditions are satisfied:-

(A) A vehicle, if it is light vehicle, should have already run for more than 1,50,000 KMs. And should be more than 5 years old in age. In case of a heavy vehicle, it should have already run for more than 2,00,000 KMs and should be more than 8 years old in age; or

(B) In case a vehicle has met with a major accident and the cost of repairs to bring it back to road worthy condition is estimated to be prohibitively high i.e. (repairs and maintenance expenditure already incurred and to be incurred exceeds for the original cost of the vehicle)

Q 6. What is the maximum time period for which a vehicle is used by Powergrid corporation of India ltd, joint ventures subsidiaries and other offices

Ans. There is no fixed time period.

Q 7. Can a person who is residing in another state participate in auction conducted by Powergrid corporation of India ltd., joint ventures, subsidiaries and other offices, for sale of vehicles which are condemned or which are not fit for use.

Ans. Powergrid does not conduct auction of vehicles for sale of vehicles which are condemned or which are not fit for use.
