G4S Facility Services (I) Pvt Ltd has provided your esteemed company Chauffeur Services from 1st of Aug-16 to 28th of Feb-19 & The contract was done basis the Minimum wage of Delhi, During the tenure of the Services provided, the minimum wage has been increased by the Delhi government numerous times.

The same has been paid to the Chauffeur's but we haven't received the differential billing amount. The revision break up has been submitted earlier also and the same is attached for your ready reference. We request you to kindly expedite the payment with regards to minimum wage revision which has been deducted against our billing since so long. We already had word with your staff Ashish Alankar(Finance) and Akhilesh Rai(Admin) but both of them have failed to give any solution to this. This is completely violation of PO and agreement which was signed between G4S and Power Grid.
