^{**} The Hon'ble CIC/SC/HC holds that though RTI Act did not specifically provide "repetition" as ground for refusal of information, it is implied from the objective and provisions of RTI Act that any citizen has right to information only once, not repeatedly. Repetitive queries for their private purpose/interest but not public interest would cause substantial harm to the legitimate Aim of RTI.
