This has reference to your application dated 28/09/2019 under RTI Act, 2005 received at this office on 09/10/2019. POWERGRID is empowered under the provisions of the Electricity Act, 2003 (hereinafter referred to as the Electricity Act) and the Indian Telegraph Act, 1885 (hereinafter referred to as the Telegraph Act) to place and maintain power transmission Towers and to draw transmission lines under, over, along or across, and posts in or upon, any immovable property. POWERGRID is having authority to finalize Transmission Line route in the techno-economic method keeping in view of all the safety aspects including in compliance with the Regulation Nos.60 & 61 of CEA (Measures Relating to Safety & Electric Supply) Regulations 2010.

Therefore, it is reiterated that construction of buildings under an existing overhead Line is not permitted.

As per section 19 of the Right to Information Act 2005, if required, you may file an appeal to the First Appellate Authority of the organisation within 30 days of the issue of this order. The address of the First Appellate Authority is given below:
