**Grounds of Appeal**


The Appellate Authority has received a postal appeal on 18<sup>th</sup> February 2020 from **Sh. Sanjay Mishra**. Earlier, the appellant herein had filed an application dated 4<sup>th</sup> January 2020, with the CPIO Corporate Centre, POWERGRID, under RTI Act, 2005, seeking copy of action taken against the complaint given by him vide letter dated 29<sup>th</sup> June 2019 to Vigilance Department of POWERGRID. The instant appeal has been filed on the ground that the CPIO has not provided information.

On receipt of the Appeal, the issue was referred to CPIO. CPIO informed that vide his communication dated 16<sup>th</sup> January, 2020, information has been provided to the appellant.

**Decision:**

I have perused the reply provided by the CPIO vide letter dated 16<sup>th</sup> January, 2020, vide which the appellant was informed that the case has been closed after approval of the competent authority. The information has already been provided to the appellant by CPIO.

The Appeal is accordingly disposed of.
