ORDER

Grounds of Appeal

The Appellate Authority has received an online Appeal bearing number PGCIL/A/E/20/00008 dated 24th February 2020, from Sh. Ashoo Srivastava. Earlier, the appellant herein had filed an online RTI application bearing number PGCIL/R/E/20/00016, dated 8th January 2020, with the CPIO Corporate Centre, seeking information related to guideline and procedure regarding brand approval given to M/s. SRMB SRIJAN PVT. LTD., located at Sagabhangra, Durgapur (W.BENGAL) for the supply of Reinforcement Bars (Steel). The instant appeal has been filed by the appellant on the ground that CPIO has not provided the requisite information to him.

Decision

On receipt of the appeal, relevant papers and information provided by the CPIO were perused. CPIO informed that the information desired by the appellant has

been provided to him vide letter dated 11th March 2020. There is a delay in providing the information. The information should have been provided to the appellant within 30 days of the receipt of RTI application. Be that as it may CPIO is hereby advised to provide the information as per the time line provided under the RTI Act, 2005.

The appeal is accordingly, disposed of.
