

<p>Query</p>	<p>a) Had you fixed main criteria domicile (J&K) for placement of NIT Srinagar student of 2019 batch in PGCIL.</p> <p>b) If so, had the same been communicated to the shortlisted candidates.</p> <p>c) If not, then why it was demanded during document verification from the shortlisted candidates.</p> <p>d) Why cannot it be treated as discriminatory and regional biasness.</p> <p>e) I think your company is not following honorable Presidents order of scrapping article 370 and 35a because your company is demanding PRC (J&K) from students who have studied in NATIONAL INSTITUTE and appearing in the interview for PUBLIC SECTOR UNDERTAKING and not the state government job.</p>
<p>Reply</p>	<p>a) The said recruitment process has been conducted under a special recruitment drive to fulfill manpower requirement in hardship areas of J&K and Ladakh for which preference has been given to local persons domiciled in these areas. However all candidates were eligible to participate in the process.</p> <p>b) All eligibility as well as selection criteria (including preference for local domicile) had been clearly mentioned in the notification sent to the institute's training and placement cell before commencement of the campus recruitment program, while requesting the institute to forward names of eligible and willing candidates.</p> <p>c) Please refer to the above replies. Accordingly, shortlisted candidates were advised to submit prescribed documents.</p> <p>d) The query aims to garner opinions/comments regarding an unfounded matter. It does not come under the definition of "information" as per clause 2(f) of the RTI Act 2005.</p> <p>e) This is a personal opinion of the requestor with no request for any information.</p> <p>However, as already mentioned, POWERGRID has asked for "domicile certificate" from only those shortlisted candidates who claimed to be domiciled in J&K as per the data forwarded by the institute.</p> <p>All candidates who were fulfilling the eligibility criteria as per the data forwarded by the institute were considered for being shortlisted for interview, irrespective of their domicile status. Having domicile of J&K was not an eligibility criteria.</p>
