

Reply:

POWERGRID has implemented the Public Procurement Policy for Micro & Small Enterprises (MSEs), 2012, as amended. Based on the policy implemented in POWERGRID under relevant packages, MSE bidders are exempted from payment of fees towards Bidding Documents and also exempted from submission of Bid Security.

Further the following benefits are also given under relevant packages:

- (i) In Supply packages, it is provided to procure 25% of the award value from the MSEs, subject to matching of L1 price in line with the Public Procurement Policy. Further, MSE bidders, not meeting the stipulated financial criteria of QR i.e. Minimum Average Annual Turnover (MAAT) & Liquid Assets (LA), may also participate in bidding provided they meet the technical experience criteria/quality aspects. However, they shall be considered for award up to 25% of the package award value in line with Public Procurement Policy.
- (ii) In case of Supply-cum-Installation tenders, main Contractors are required to furnish details of the items, components, raw material, services procured/availed from Micro and Small Enterprises for the purpose of completion of works.
- (iii) In line with the GoI directives on 'Make in India' policy of GoI and POWERGRID's own procurement policies, relaxed Technical experience route including Collaborator route, Licensor-Licensee Route etc. have been provided to Indian Manufacturers which inter-alia include MSEs, in the Qualification Requirement (QR) stipulated for various packages.
- (iv) In case of financial criteria of QR, relaxation of 20% in financial criteria of MAAT & LA for an MSE bidder or START-Up bidder (as defined by DPIIT) is being considered by POWERGRID i.e. an MSE/ START-Up bidder meeting 80% of the MAAT and LA requirement for a particular package shall be considered qualified on these aspects for award of the whole of package.
